**Approval of Minutes:** March minutes are on hold until Donna Troppoli's return. April minutes were approved with several changes.

**Public Comments:** Charlie Horner discussed the arduous planning of the Light of Day Exhibit scheduled to open in the Heaven Arts and Antiques Gallery on January 15, 2015. It will remain there for two weeks before moving on to Monmouth University. Many items and memorabilia will be included. This is to be a major exhibit The title is to be announced.

**COMMITTEE REPORTS:**

**Budget & Finance: Treasurer, Mary Damato**

The balance between the Crane House and the Historical Society is \$15, 124.

Member John Grant will help Mary transition our record-keeping to **QuickBooks software**. This would encompass data from January 2014 to the present for each, the APHS and the Stephen Crane House accounts. Jim Henry will help John structure the financial statements. QuickBooks codes will be given to Donna, Jennifer and John Grant. Someone asked whether there are bank fees: yes.

**Membership: Kay Harris, chair**

March: 3 renewals, 1 new member.

**Web Site and Media: Jenny Schulman, chair:**

Jennifer has proposed the use of WordPress platform that would accommodate interactive features, e.g., a calendar, image galleries. WordPress also would work with the various sizes of electronics, i.e., phones, tablets, computers. A committee was selected to work with Jennifer in selecting a template: Teddy, Eileen, Kay.

**Fundraising and Special Events: Eileen Chapman and Teddy Chomko, co-chairs**

Teddy is working with Ruthanne Harrison, a local promoter and former trustee for a fundraising event. A house tour is being considered for November – food in people’s kitchens, history of the houses. Christmastime. Note: Ocean Grove’s biggest money maker is their house tour.

On August 17<sup>th</sup>, Teddy has arranged for art on the boardwalk and is charging \$75 for each artist.

Christmas bus tour: perhaps a discount ticket to “Scrooge” will be offered. (Mark Fleming, Premier Theatre)

Aug. 3 - Open House: Don and Eileen will work on this. Sunday, August 3<sup>rd</sup>.

June 8 – Paranormal event. Proceeds will go to A.P.H.S.

Note: the old Palace Amusements carousel is for sale on eBay. Don will appeal to Chris Flynn who could possibly get a grassroots movement going to acquire the historic icon. Don will also speak to Kate Mellina about getting the preserved barrel from the Palace.

**Membership: Kay Harris, chair**

Susan will work with Kay to solicit volunteers and maintain a table inside Convention Hall in front of Kay Harris’ Asbury Galleria. Several people have volunteered.

Jennifer suggested that we acquire heavy plastic signs for visibility
